2. Hazards Identification

Emergency overview Aerosol. CONTENTS UNDER PRESSURE.
Will be easily ignited by heat, spark or flames. Prolonged exposure may cause chronic effects.

Potential health effects

Routes of exposure Ingestion.

Eyes Health injuries are not known or expected under normal use. Contact with liquid or mist will irritate the eyes.

4. First Aid Measures

First aid procedures

Eye contact Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Skin contact Take off immediately all contaminated clothing. Wash off with warm water and soap. Get medical attention if irritation develops or persists.

Inhalation If symptoms develop move victim to fresh air. Get medical attention if symptoms persist.

Ingestion If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. If ingestion of a large amount does occur, call a poison control center immediately.

6. Accidental Release Measures

Methods for containment	Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.
Methods for cleaning up	Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Handling	Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid contact with eyes. Avoid prolonged exposure.
Storage	Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Do not handle or store near an open flame, heat or other sources of ignition. Do not expose to heat or store at temperatures above 120°F/49°C as can may burst.
